26	History/Development	Haxey parish has the largest number of registered footpaths as a Parish in the England. They are a combination of what were termed occupational trods and ancient highways. While the trods were mostly to service the strip farming, a large number were registered as public rights of way in the late 1990's. They can be problematic for land owners, as people do not stay on them, they provide access for poachers and other criminal activities. It is recognised they could provide a good network for
		walkers, horse rider and bike riders. Whilst all are accessible by able bodied people, some are difficult to navigate for the disabled and a full survey of the complex needs to be carried out to identify and remedy problem areas.
27	Aims & Objectives	Carry out a full survey of the Parish footpath and bridleway complex. Also to have some footpaths upgraded to bridal ways and allow bicycles which may need some legal changes to allow(creating bye laws may be a mechanism) We would be opposed to the higher status of restricted bye way as it would mean no effective way of restricting motorised vehicles and the associated problems. We would also seek considerable funding for proper gating of all access to the network to stop misuse.
		Given NLC is currently trying to create access for Horse Riders and bicycles with this aim it would make sense for them to carry this project forward and we have a watching brief to A be kept fully informed as to plan routes B to ensure the above recommendations are implemented. C Ensure current Horse Riding lobby does not control direction of our footpath infrastructure. No costing required for this activity as NLC are carrying out the survey and there is a Haxey Parish Councillor on the group; however, we do need to address the open access issue to the complex.
