2025/113 – application to determine if prior approval is required for a proposed change of use of agricultural buildings to create one single storey dwelling house (use class C3) under class Q at Apple Tree Cottage, Brackenhill Road East Lound Road, Haxey.

Resolved – object with the following comments:

This site is a former farming business, it has had numerous applications on the site as a whole, which make it difficult assess this request. This is a prior approval application and as such our concerns and questions are as detailed:

How many applications have been granted under part Q?

Was this ever an agricultural business and is there any evidence of the agricultural buildings for the purpose of farming, and if not this doesn't conform to Class Q? Was this building granted permission after ceasing as an agricultural business and was it used as an agricultural building?

Due to the site history, we are unable to answer these questions and would ask the officer to look at our concerns and establish whether this application conforms to part Q.
