# **HAXEY PARISH COUNCIL**

Minutes from the meeting held on Tuesday 24<sup>th</sup> June 2025 at 7pm at the Foreman Carter Centre, Westwoodside.

2506/02 Resolved - to temporarily suspend the meeting for a period of normally, no more than 15 minutes, but at the Chairman's discretion to allow for a period of public participation. Ward Cllr Kennedy advised there is a Teams meeting on 2 July 2025 to discuss the proposals. Cllrs Booth, Carlisle, Harris and Holgate will attend. Cllrs voiced their frustration with the plans.

- 2506/10 To discuss vehicular access to Northside determining any actions required.
  - The Principal Access and Commons Officer's opinion is that it would be prudent to see if signage alone has the desired effect to restrict vehicular access. There has been no progress on the signage yet. Clerk to investigate the cost of moving the mobile camera to this location.
- 2506/11 To determine actions required regarding the state of repair to various pavements in the parish.

  Ward Cllr Kennedy advised that a trial of a new machine for repairing potholes has been undertaken by NLC. This is being costed up by them at the moment.
- 2506/12 To receive the North Lincolnshire Local Plan Initial Engagement and Call for Sites Addendum and Draft SCI consultations, May 2025 and consider any action required.

The Council's comments remain unchanged from the previous draft Local Plan. The area east of the Primary School at The Nooking is a site suitable for development.

# Reports / Updates

2506/13 To receive a report from the Ward Councillors on activities within North Lincolnshire Council. Ward Cllr Kennedy updated the Council on the following issues:

There is a post 16 travel initiative if the pupil lives more than 3 miles from the school.

The bin at Blackmore Bridge has been replaced twice due to vandalism. NLC will replace this bin again but will take it away altogether if this is vandalised again.

Signage at Vinehall Road and Hallcroft Road will no longer be replaced by NLC. This is not enforceable.

If a crime is witnessed this should be reported to the Police as this helps with the number of hours of support the parish gets.

Bullrushes require cutting back to improve vehicular visibility on the bend.

Cllr Parkin will pursue the disposal of the waste from draining and clearance of the pond and check with the Environment Agency.

A meeting has been held, and the minutes will be circulated. 2 planters are still awaited for Haxey and

1 more is needed for the Low Croft bed. 1 more hanging basket is needed but there are spares available to be used. £2,400 has been spent from the budget.
